Context and background

The “Innovating the use of Labour Market Intelligence within European Universities” (acronym: LMI-EUniv) is a project funded through Erasmus+ programme, Key Action 2 – KA2 - Cooperation among organisations and institutions / KA220 - Strategic Partnerships for higher education of the Erasmus+ programme. The project has started on 28.02.2022 and it is a 26-month length with the end date being 27.04.2024. The primary focus of the project is to understand how European Universities are using labour market information and labour market intelligence in the planning and delivery of their provision and how can this be improved. The project is developed on three directions: (1) Mapping essential LMI sources at national level, (2) Exploring how HEI in Europe are using LMI, and (3) Production of a Training course, guide and a LMI HUB.
